The Freedom of Information (Scotland) Act 2002 (the Act) requires Scottish public authorities to produce and maintain a publication scheme. Authorities are under a legal obligation to:

- publish the classes of information that they make routinely available
- tell the public how to access the information and what it might cost.
- this 'Guide to Information' has been produced as a requirement by the Scottish Information Commissioner, in terms of the Model Publication Scheme.

Availability and formats

The information we publish through the model scheme is, wherever possible, available on our website.
