### **BACKGROUND AND INFORMATION**

#### **Santander Universities**

Santander Universities was first created in Spain in 1996 by Emilio Botín, who recognised that universities play an important role in society. He believed that Santander should support these institutions through the provision of scholarships, mobility awards, entrepreneurship funding and much more. In 2007 the scheme was launched in the UK and now has partnerships with over 80 universities, providing over £10m of funding in 2017 to support university staff and students. Abertay University is the latest institution to join the prestigious Santander Universities network.

Santander Universities supports the following activities and opportunities at Abertay:

**The Santander Opportunities Fund** – Funding has been allocated for work placements, conference travel and visits to partner universities for students who have financially challenging circumstances.

**The Santander Internship Programme** – A number of companies have offered internships for Abertay students over the summer of 2019 with Santander match-funding the salary for these internships. **Support of Entrepreneurial Activities** – Funding has been allocated for entrepreneurial activities such as a professional speakers programme, assistance with the incubation of early stage businesses and enterprise events within the University. ### **OPPORTUNITY ELIGIBILITY CRITERIA**

The Santander Opportunities Fund has been set up to support activities which enhance the student experience and support the internationalisation of the student body, both on and off campus. The aim of the fund is to support student mobility and employability, particularly from Widening Access/ Participation backgrounds. Applications are invited from both undergraduate and postgraduate students who meet the individual eligibility criteria.

Examples of activities that the Fund may support include:

- A. Attendance at a high profile Conference or Event that will enhance employability as well as providing the opportunity to travel outside of Dundee/Scotland.
- B. An unpaid work placement (as part of a course) that the student would not otherwise be able to undertake due to financial insecurity/travel and other costs.
- C. A summer Internship that the student would not otherwise be able to undertake due to financial insecurity/travel and other costs
- D. Travel abroad to visit a partner university where students may take advantage of state-of-the-art facilities and teaching. (Contact our International Officer <a href="mailto:international@abertay.ac.uk">international@abertay.ac.uk</a> for more details of applicable opportunities)

Other opportunities which the applicant feels meet the fund criteria will be considered on a discretionary basis.

### INDIVIDUAL ELIGIBILITY CRITERIA

Applications are invited from students from who fall into one or more of the following groups:

- 1. Students with a household income\* under £34,000 (discounting personal earnings)
- 2. Care Experienced students
- 3. Students under 25 who are irreconcilably estranged from their parents/guardians
- 4. Students with disabilities or long term medical conditions (including specific learning difficulties and mental or physical health conditions)
- 5. Students who are single/lone parents
- 6. Students with caring responsibilities (A carer is anyone who cares, unpaid, for a friend or family member (including children) who due to illness, disability, a mental health problem or an addiction cannot cope without their support)
- 7. Applications will be considered from students with other exceptional circumstances which have a significant financial impact on their ability to undertake an eligible opportunity (please discuss with a Student Advisor before applying)

### WHAT KIND OF FUNDING IS AVAILABLE?

**The maximum award value is £2,000**. Students may apply for an award to contribute to or meet the cost of travel, event fees, incidental expenses and/or accommodation.

<sup>\*</sup>For the purpose of this application household income is considered to be any income that SAAS, Student Finance England/Wales/NI would take into account when assessing a student for means tested funding (information available online). Self-funded or postgrad students who have not undergone a means tested assessment may contact the Advisory Service for more information on how to calculate and evidence this.

Awards for internships and placements will be considered for up to a maximum of 4 weeks of support at £160 per week plus travel expenses if out with Dundee.

Payment arrangements will be at the Discretion of the Decision Making Panel.

Awards for event fees, travel and accommodation will usually be paid direct to successful students in 2 instalments. However, in some cases the University may make the travel and/or accommodation arrangements on a student's behalf.

- Payment 1: Travel, Accommodation & Event/Ticket Costs
- Payment 2: Expenses (released after receipt for travel, accommodation and event costs have been provided)

Awards made towards placement/internship living costs and/or expenses will be paid directly into the applicant's bank account.

### **AWARD CONDITIONS**

Applicants must be willing and able to meet the following award conditions if successful:

- 1. To submit a short report about your experience undertaking your chosen opportunity
- 2. To give permission for elements of your report to be quoted for promotional materials
- 3. To meet with the Donor at the Donors request
- 4. To take part in promotional activity relating to this Award
- 5. To provide receipts related to your opportunity costs if requested

### **APPLICATION DEADLINES**

Applications will be considered by a panel four times a year. Deadlines and *suggested* opportunity dates are listed. Applications may be considered out with these dates in *exceptional cases*.

### **HOW CAN I APPLY?**

Applications may be downloaded and completed on a device or printed and completed by hand. A typed signature may be accepted where the application has been completed electronically.

Applications must be submitted with the supporting evidence detailed in the application form.
