The Role

We are looking for two individuals with a mixture of skills to join the University's Audit & Risk Committee as external members. Appointment to the Committee will offer successful candidates an opportunity to contribute to the effective governance of a modern, pioneering and ambitious Scottish Higher Education Institution based in Dundee.

We are particularly interested in candidates with experience in one or more of the following areas:

- Audit and financial control
- Corporate governance issues
- Risk management
- Strategic finance

A professional qualification is not a pre-requisite but would be an advantage.

Audit & Risk Committee

The role of the Audit & Risk Committee is to provide the Abertay University Court with such advice as it considers appropriate on matters relating to audit and internal control to assist Court in ensuring the proper discharge of its responsibilities for proper financial management, for the effectiveness of the internal control and management systems, for the safeguarding of the assets of the University and public funds, for the economy, efficiency and effectiveness of the University's activities, and in regard to risk management and corporate governance and the conduct of the University's operation.

Terms of Appointment

Expenses

The role is not remunerated, but individuals are entitled to all travelling and incidental expenses (including, for example, childcare costs) incurred in the course of University business.

The Audit & Risk Committee meetings are conducted in a hybrid manner, therefore external members are able to join online via Microsoft Teams if they wish to do so.

Period of Appointment

The appointment is for two years with the possibility of a further two-year period of office. Appointed candidates will also be welcome to apply for full membership of the University Court whenever vacancies arise.

Time Commitment

The Committee meet a minimum of four times per year with each meeting scheduled for 3 hours. The Audit & Risk Committee dates for 2023-24 are:

7 November 2023; 30 January 2024; 26 March 2024; and 28 May 2024.

Successful candidates may also be invited to participate in related University events or meetings.

The University Court is the Governing Body of the University and its powers are set out in the University's constitutional document, which is "<u>The Abertay University</u> (<u>Scotland</u>) <u>Order of Council 2019</u>'. We pride ourselves on offering an inclusive, friendly and welcoming environment for our students and staff alongside first-rate teaching and excellent student experience.


